VII. State Agency Coordinating Team (SACT) - Funders Reports

- a. Kendall Maier AGO (kendall.maier@azag.gov)
 - i. VRP Agencies:
 - 1. All agencies have had their FY25 Performance Reviews approved. We are waiting on notification of the AGO's budget before moving forward on opening up agencies' budget proposals for FY2025
 - ii. Education:
 - 1. Basic and Advanced Victims Rights presentation dates listed through June have been posted on the AGO website for open registration
 - iii. Law Enforcement:
 - 1. All law enforcement agencies using the statewide multi-copy RW forms had been invited to two meeting early March, where the AGO discussed that they will no longer be providing printed versions of the form and has ADOT host a TraCS demonstration. The AGO will maintain annually updating the RW form and distributing it via email to LEAs and updating in TraCS system. This is the last year (FY2024) that the AGO will be

providing printing services. FY24 RW form orders have been open and will remain open until March 29, 2024. The discontinuation of printing will begin Sept 2024. Any problems or questions can be directed to OVSVRP@azag.gov

- b. DPS-VOCA Carla Uyeda (cuyeda@azdps.gov)
 - i. DPS-VOCA distributed a Crime Victim Fund Discussion update on 01/23 which stated that the AZ Governor's Executive Budget had been released and includes a recommendation of \$9.3M from the General Fund to backfill VOCA
 - ii. If approved, this would mean current DPS-VPCA subawards could be renewed in FY25 for an additional twelve-month period at approximately the same levels as FY24 subaward amounts
 - iii. Should the recommendation not be approved, current subawards could be renewed in FY25 for an additional twelve-month period at approximately 50% of the FY24 subaward amounts
 - iv. At this time, DPS is projecting a renewal award process for FY25, but it is unclear at precisely what amount or level
 - v. Invitation to apply for a renewal award will likely be send in Aril 2024
 - vi. Current subawards are approaching half-way mark of FY24. February expenditures should be near 42% and March expenditures should be near 50%. It is critical for subrecipients who are behind on spending address unutilized funds via an amendment to either reprogram or reduce the budget
 - vii. March financial report is due 04/15
 - viii. Site visits continuing, Civil Rights Compliance reviews continuing
 - ix. June 30 deadline, if you are realizing that you have currently have unutilized funds, make those changes now. You might hear from coordinator if you are behind on spending.
